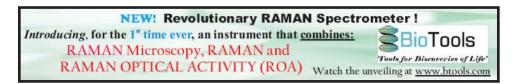




November, 2009 SAS ACTIVITIES AT FACSS AND REPORTS

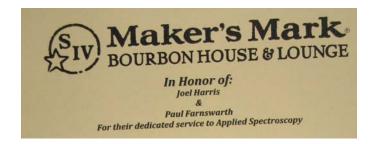


SAS Student Event at FACSS

We have renewed our relationship with OSA with a three year extension to our original contract to offer our journal to their subscribers. This has proven to be a financial success for SAS and has broadened the appeal of the journal.

The 2009 Tour Speaker program went very well. Plans for 2010 are already underway under the able helm of Joe Caruso. Speakers have been selected and sections will be able to schedule their tour in the near term.

A. Online Journal - Paul Farnsworth reported downloads have increased, and we are hoping to see increase in citation. Paul claimed numbers do not seem very reliable, especially those form OSA, and urges new Editors to push for more detail. He discussed top downloads for OSA and Ingenta. The Journal is becoming less attached to Society, due to on-line, makes selling it as a benefit less obvious to members.

B. Journal Publishing – Print vs Online. Fred LaPlant raised the question as to cost of printing on paper. Savings would be about a third of budget, but cost would be loss of ads—which currently pays for about half the cost of printing—and a loss of potential member benefits. Currently "on-line" is not widely accepted for our journal dissemination, since a larger percentage of members chose (80%) paper even with an extra charge.

C. Student Issues - Michelle Meighan suggested doing something at Pittcon beyond the social event, which is taken as positive. At the retreat the idea of a poster session, perhaps on Sunday with prizes and food was developed. Suggestion was made to grow this student event on the current poster/reception on Sunday, and involve Analytical Chem Div. as well.

D. Web Editor position – Candidates are needed for this Exec Comm member (3 year position). This person needs to have working knowledge of computer Web sites (technical awareness) and needs to post up data if needed by various parts of Society, but the new web site goal is that each section coordinator should be able to update his/her section with instruction. The Committee must develop a job description, statement of potential job load, and then we will seek nominees for the position.

Returned to this topic, interrupting New Business, when guests arrived later – 10:15

E. Applied Spec Ad Updates Ed MacMillan and Bill Cunningham. Report provided by Ed. He took over advertising a year ago, and we had a good year, 75% increase, 11 new advertisers. The Reader Survey helped demystify the market. Our 50th anniversary suppliment big success, picked up some new vendors. On-line ads are coming. 2009 should hold at this level, growth might be tough. 2010 is really unknown. Big companies walking away from print ads, we are moving into unknown territory. Question: is stimulus money going to help? Smaller companies are holding OK from his view. At FACSS he will have ad renewal season going, and estimate year end numbers. He offered complaints about Ingenta related to customer service. He started a discussion of electronic publishing, noted we need a format to get ads live, with just a pdf format we will lose all ads. Need the ads to link to Websites of Advertiser. Joel suggest put A pages on line, has Ads and Whats New. This means Table Contents, Focus Articles, given away but it could increase traffic and citation. Allen Press knows how to use this. Ed was asked for a proposal to set this up with hotlinks to Ingenta site for papers. The current problem with Ingenta is registration. We could e-mail announce/link to membership. But make it available to whomever wanted it, and wanted to see the ads. Eventually link to the SAS site with abstracts would be good, and could have a membership page for sign up as well. Annual price increase for libraries, Bill suggest 2-7% is norm, higher increases catch problems. Most have some increase. Allen does a buyers guide to compare journal pricing.

A. Membership and Subscription Fees for 2010 - Joel Harris, Bonnie Saylor. Question raised: should rates be increased gradually, but trying to partner with OSA-match their changes. No information from them yet. Sought permission to go up a maximum of 3%. OSA has >30% of library subscriptions as a bundle, which may hold better than individual SAS ones. TABLE initially, then Post discussion above with Allen Press (above). Paul Moved John sec that the subscription rate be increased by a max of 3% pending input from OSA. Pass Unanimously. Discuss if go for no increase in membership fee, or drop on-line only cost as a test. Paul move John second to decrease on-line membership fee by \$5. Pass unanimously.

B. Grad Student Award/Bylaw Vote - Bonnie Saylor. TAK move Paul second to adopt the recommendation of the ByLaws Committee (see attached). Pass unanimously. In this change, the SAS Graduate Student Award was renamed in honor of Barbara Stull Jon move Paul second to fund Barbara Stull's two daughters to the Louisville meeting for first presentation. Pass unanimously.

C. Membership Coordinator - Bonnie Saylor

Gloria Story is at the end of her term, and is willing to take on a new term, if appointed. Paul move John second Executive Committee recommend to the Governing Board that she be reappointed for a second 3 year term. Pass unanimously.

D. Voting on Awards All

Emeritus Membership – plaque and free membership for long time members

Paul move, Fred sec Nomination of Jack Fuchs for Emeritus membership be approved. Pass unanimously.

John move, Fred sec Nomination of Robert MacDonald for Emeritus membership be approved. Pass unanimously.

Jon move, Paul sec Nomination of Joel Harris for Distinguished Service Award be approved. Pass unanimously.

Honorary membership-plaque and free membership for long time members, automatically a fellow

Paul move, TAK sec Nomination of Geraldine Richmond for Honorary Membership be approved. Pass unanimously.

Fellows Fred move Paul second that we approve the recommendations of the Fellows committee be accepted with the provision that all are members at time of the presentation of the award. Pass unanimously.

E. Voting on Officer Nominations All—to take office Jan 2010

Paul move Fred second acceptance of nominating committee recommendations for President-elect (Curt Marcott and Debbie Bradshaw) and Secretary-elect (Katherine Bakeev and Augustus Way Fountain) to be voted on this summer by the society.

F. Other opportunities for special issues/supplements-Discussion

Wilks symposium might be an opportunity, or every so often have an anniversary issue.

Special issue ot commemorate selected people, typically this will use an article summarizing work and articles dedicated to that person by others. Problem is one of finding time and content.

Special issue could be created by use of some content we already have, Meggars or most cited, question of print or alternate version. Maybe use anniversaries to help generate some interest at various levels

Report to the SAS Executive Committee and Governing Board Peter R. Griffiths, Journal Editor **September 25, 2009**

Applied Spectroscopy has run smoothly since the last Governing Board meeting in October, 2008, despite the change in editors, several associate editors and many of the editorial board. On July 1, I took over from Joel Harris as Editor-in-Chief, Mike Blades has taken over from Paul Farnsworth as Editor, and LeNelle McInturff has taken over from Jenny Jensen as the journal's Editorial Assistant. LeNelle and I spent a very productive two days with Jenny and Joel in June learning the ropes and the transition was remarkably seamless. The new associate editors are David Hahn, John Kalivas, Rich Mendelsohn, Yuki Ozaki and Zhong-Qun Tian, with Neil Everall remaining; several of them have all served already as associate editors for some new submissions and reviewers. Katherine Bakeev, Arne Bengtson, Antonio Carlos Bento, Rohit Bhargava, Paul Farnsworth, Naoki Furuta, Kathy Gough, David Griffith, Pavel Matousek, Jurgen Popp, Rick Russo and John Wright joined the Editorial Advisory Board. Max Diem, Detlef Gunther, Katrin Kneipp, Carol Korzeniewski, Bernhard Lendl, Curt Marcott, Larry Nafie and Mike Pelletier will continue on the Editorial Board. This group of topquality scientists represents many of the important spectroscopic disciplines and the geographical regions from which most of our

manuscripts are submitted. Enormous thanks are due to the people who served previously. Besides Joel and Paul and others who moved into other editorial roles, these were José Broekaert, Bonner Denton, Ted Eyring and Hiro-o Hamaguchi (Associate Editors) and Robin Garrell, Akbar Montaser, Mike Morris, John Olesik and Jeanne Pemberton (Editorial Advisory Board.)

In 2008, 1 accelerated paper, 174 regular articles, 14 spectroscopic technique papers, 12 Notes, and 6 Focal-Point articles were published. The total number of articles printed was 207, which is not significantly different from the previous four years (see table at the end of this report.) The number of manuscripts received for review was 356, which represents an increase of 40 from the average of the previous four years, indicating the continuing vigilance of the editors and reviewers in requiring that papers be of excellent quality. The rejection rate for *Applied Spectroscopy* increased to 44% in 2008, a figure that is consistent with top quality journals.

Comparisons with previous year's statistics are included on the attached table. Although the number of Focal Point review articles published increased to six last year, no Focal Point articles were published for the first half of 2009. However, Focal Point articles will be published in the September, November and December issues, thanks to the efforts of the Focal Point Editors, Ben Smith and Rina Dukor. The number of review articles has a significant effect on the Impact factor of the journal and it is important that at least six Focal Point articles should be published each year. To this end, I have asked John Chalmers to join Rina and Ben as a Focal Point Editor and he has agreed to do so. With John's influence, I hope that we will increase the number of European authors writing Focal Point articles. Suggestions for new topics and authors from any member of the Society are always welcome.

The value of the Impact Factor (*IF*) is internationally regarded as a measure of the quality of a scientific journal. The *IF* is a measure of the frequency with which the "average article" in a journal has been cited in a particular year. The Impact Factor for 2008 is determined by the ratio of the number of citations in 2008 to articles published in *Applied Spectroscopy* in 2007 and 2006 (835) to the number of articles published in those years (405). Thus the *IF* for 2008 was 2.062. This number indicates a gradual increase from previous years (1.902 for 2007, 1.879 in 2006, 1.868 in 2005, and 1.848 in 2004.) (These data were taken from ISI's *Journal Citation Reports*.)

However, the Impact factor is still significantly lower than the values for more specialized spectroscopic journals, such as the *Journal of Raman Spectroscopy* and the *Journal of Analytical Atomic Spectroscopy*. Stimulated by an important letter from Pavel Matousek, the Associate Editors and members of the Editorial Board are looking into ways of increasing the *IF* above 2.5.

Despite the relatively low Impact Factor, the articles in *Applied Spectroscopy* do have immediate impact as reflected in *Citation Reports'* Immediacy Index of 0.208. This index indicates that 20% of the articles in the journal are cited during the same year in which they are published. The citation half-life of the journal is currently 8.1 years. This metric means that scientists continue referring to our papers for many years following publication.

The two biggest problems that I have encountered in the 3+ months that I have been Editor-in-Chief of the journal have been getting top-quality scientists to agree to review more than one or two papers a year and actually receiving reviews within one month of the manuscript being sent out. There is also a problem in getting uniformly well thought out reviews, especially from scientists in developing nations. For example, the journal is receiving a greatly increased number of high-quality manuscripts from mainland China, but the quality of the reviews from this country is not always high. I believe that it is unfair to bombard scientists in the more developed nations in North America and Europe with manuscripts but have not yet come up with a better approach. Again, any suggestions as to how to ameliorate this situation would be greatly appreciated.

As noted by Joel Harris in his report for the EC meeting at Pittcon 2009, the production costs for the journal are staying below budget thanks to continued aggressive management of manuscript quality, length, and color page costs, along with control of error costs in proofs, figures, and production, thanks in large part to our Production and Composition Editor, Rebecca Airmet. Rebecca provides format-marked manuscripts electronically to Allen Press including equations, so that the papers are effectively typeset by her. This system allows a short time period between manuscript acceptance and print publication, currently only 2 months for regular articles in the journal. This speed puts *Applied Spectroscopy* in the category of a rapid-communication journal, even for our regular articles. Accelerated papers can appear in print within 5 weeks after acceptance. Allentrack, the electronic manuscript submission, reviewing, and tracking system at Allen Press, has also been running well.

There are few complaints, and we receive a number of compliments from authors and reviewers alike. Response from Allen Press is outstanding. As an example, I requested that a place should be added to the manuscript submission web page where authors can include the names of up to four potential reviewers. This was added ONE DAY after I made the request!

Thanks to the efficient efforts of the Meggers Committee chair, Pavel Matousek, and his committee, the 2008 Meggers Award paper was selected and is "A New Method for the Time-Resolved Analysis of Structure and Orientation: Polarization modulation infrared structural absorbance spectroscopy" by Yongri Liang, Damien Mauran, Robert Prud'homme and Christian Pellerin of the University of Montreal {Appl. Spectrosc., 62(9), 941-947)}. Christian Pellerin will give a plenary talk at FACSS on this work and the paper is being recognized in a symposium at FACSS.

Our initiative for developing cooperative publication arrangements with the Optical Society of America (bundling of our library subscriptions, addition of *Applied Spectroscopy* to OSA's InfoBase web collection of OSA journals) became effective January, 2007. In

2007, we totaled 68,248 full-text PDF downloads of articles from *Applied Spectroscopy* through InfoBase. This number exceeded the 51,427 full-text article downloads that were provided through Ingenta that year. Since then, OSA distinguishes between "filtered" and "unfiltered" downloads. The "filtered" numbers have the activity of the OSA staff, Google Scholar, and CrossRef removed. (In the past, only unfiltered activity was reported.) In 2008, there were 63,148 filtered and 171,764 unfiltered downloads. Between January 1 and August 1 there were 41,893 (62,840) filtered and 80,265 (120,400) unfiltered downloads. (The numbers in parentheses are the estimated numbers for the entire year of 2009.) One reason the 2008 "unfiltered" downloads are so high is that OSA output new indexing files for Google throughout the year, and there are a large number of *Applied Spectroscopy* backfiles. Scott Dineen (Deputy Senior Director of Publications for OSA), who supplied me with this information, noted that *Applied Spectroscopy* papers have become an important part of their *Virtual Journal for Biomedical Optics*. More than 10% of *VJBO* content has been from *Applied Spectroscopy* this year (accounting for 67 of VJBO's 659 articles published Jan-July). The reach of *Applied Spectroscopy* is being expanded, primarily through OSA's consortia sales efforts for Optics InfoBase (IB), as can be seen from the following statistics, the trend of which is expected by OSA to continue through 2010.

In 2008, our OSA-hosted article downloads have nearly doubled from last year's rate, totaling 63,148, compared with 48,370 delivered by Ingenta over the same period. OSA is more than doubling the electronic distribution of our content. This increased readership should improve our impact and citation statistics in the future; it should also bring more manuscript submissions to the journal.

Society for Applied Spectroscopy Web Editor's Report September 30, 2009 Stephen Bialkowski)

There have been no major changes to the web site since the last report. I have been performing routine maintenance of the Society's web site. This includes meeting posts, updating membership forms, society news, checking and verifying links, updating the Corporate Sponsor lists, links, and logos, and performing miscellaneous tasks such as deleting old content.

Web extensions have been broken for a while. The internet service provider was contacted several times over the past year. The solution was not found with their suggestions. I subsequently programmed some of the dynamic functions using cgi scripts instead of the Microsoft web extensions.

The web use tracker indicates no major changes to the SAS web site access. But access has declined since a high in October, 2005 when 144 different persons accessed the site. The average over the last ~5 years is 77 accesses per month. Last month the SAS web was accessed 57 times. Although I have no data to indicate why, I suspect that there are more competing web sites as time goes on. 60.38% of the web site access has been from within the United States. This is followed by Europe and then Asia. The main European countries are UK (3.1%), Germany (2.77%), France (1.52%) and Netherlands (0.99%). The major Asian countries accessing the SAS site are Japan (5.05%), Iran (1.54%), China (1.35%), Taiwan (1.13%), and India (0.91%).

Membership Coordinator's Report September 2009 Gloria Story

The membership committee met during PittCon 2009 on Tuesday, March 10th (7:30 to 9:00 AM, Hyatt Regency Chicago – Dusable Room); those in attendance were Michelle Meighan, Mike Carrabba, Pavel Matousek, Bonnie Saylor, Debbie Bradshaw, John Chalmers, Fred LaPlant, Jon Carnahan, David Heaps, David Butcher, Paul Bourassa, and Gloria Story. The agenda included a review of the plans for the "Day at the Races" members-only event at FACSS 2009 (Bonnie and Debbie), an update on our new UK regional section (Pavel), and a progress report on our new website (Jim de Haseth sent a report).

Day at the Races Members-only Event: This will be a free event for the first 100 members to sign up with bus transportation from the hotel (10:45 AM) to the Triple Crown room at Churchill Downs, a 3- hour buffet (noon to 3) of sandwiches, salads, and side dishes, 4-hour open bar (noon to 4), and horse racing programs (a member may pay for a guest to attend, as space permits). Our New Website: Jim provided a progress report on our new website design. Each member of the Society will have a profile that they can edit (addresses, email, passwords, etc.). If the cost can be kept reasonable, the ability to pay online is planned. Access to the Member Directory will be handled with permissions set by the administrator and it will be searchable by several category types. Information about current and past officers, committee members, and award winners will also be available. The Membership committee looks forward to being beta testers.

Previously reported, our chair-elect, Fred LaPlant, established our latest member benefit, a SAS members only group within the cyber space world of "**LinkedIn**". As of this writing, there are 242 linked members. Report of the SAS Awards Committee FACSS 2009

The awards committee has selected Larissa Finn and Arindam Ganguly as the winners of the 2009 Graduate Student Awards. We had an excellent and large group of candidates to consider and the choices were not easy. We would have loved to give more than two awards this year. The list of candidates was impressive and overall their work is as worthy as the two winners. We independently considered and weighted many factors. Each committee member found many strong candidates. We examined the scope, difficulty, and novelty of each research problem and its potential impact, the research vision and probability that the student's work will serve as a foundation for future work or open a new arena, a general assessment of each student's overall demonstrated abilities, and their presentation and publication records, including the quality of the journal or venue, the magnitude of the work, and the number of communications. The strength of the recommendation letters and the writer's relationship to the student also were considered. With Arindam Ganguly and Larissa Finn, we felt that their research was not only thorough, but will have a large impact on their fields. While they might not have been the clear winners in each criterion given the strength of the applicant pool, taken collectively, Larissa and Arindam were the strongest candidates. SAS Publicity Committee Report 31 August 2009 Prepared by Chad Leverette (Chair)

The Publicity Committee did not meet at PITTCON this past Spring. Communication between committee members occurred this summer through e - mail exchanges. We will not be able to meet at FACSS due to the fact that all committee members will not be present. The committee has decided to hold a conference call later in the Fall to further discuss ways to publicize SAS.

The committee, at this point, is interested in seeing if the Members - Only event that is planned for FACSS 2009 is a successful strategy for publicizing the Society and attracting new members. We also hope to gauge how effective the FACSS website is in publicizing SAS to conference attendees.

To date, our committee has one suggestion that we would like the Executive Committee to consider.

- (1) Publicize the Society and the journal to researchers who are using spectroscopy in very specialized disciplines where spectroscopy is not the focus.
- (A) This could be accomplished by placing advertisements in conference program books for meetings where spectroscopy is not a focu (such as bio or medical oriented conferences where attendees may be using spectroscopy for certain applications).
- (B) Sponsoring a focused symposium at FACSS or PITTCON and inviting noted speakers in these very specialized fields, with expertise in areas other than spectroscopy, to describe their work and how they use spectroscopy or vice versa (holding an applied spectroscopy symposium at a specialized research conference).

One of our committee members recently made a job switch between two specialized research fields and realized that he had many coworkers in his new position that were using spectroscopy but were not familiar with SAS or our journal. These researchers were not "trained" as spectroscopists, but rather worked on projects that required the use of spectroscopy in innovative ways. In this specific case, these scientists were typically publishing in more biology - related journals and attended more specialized medical conferences focused on that particular research niche. The goal of this approach is to target scientists that have expertise in other areas, but who are users of spectroscopy, in order to enlighten them about the benefits of our Society and our journal.

Tellers' Committee Report FACSS 2009

Report to SAS Executive Committee Ed MacMillan, Allen Press Advertising Sales September 2009

2009 has been another good year for Applied Spectroscopy advertising sales. Many factors have contributed to this, these include:

- We built on the hard work from 08
- Even more investment in the sales department at Allen Press
- Building on the marketing we did on 08



Although all of this helped bring in more revenue the most important factor was the emphasis placed on *Applied Spectroscopy* by the sales department. This journal is an outstanding example of a journal that not only emphasizes relevant cutting edge research but one that does this in a relevant inclusive manor.

Below are the advertising revenue numbers to date. Note since November and December are not closed these may change hence the *italics*.

Our goal as reported to the executive committee last March was to capitalize on the gains made in 2008. As you can see we not only did this but have increased the number by about 28%. Considering the economy is in recession and print advertising is well down across the board, this was no mean feat.

Also, this year we did not have the additional 50th anniversary supplement which meant we were down \$20,000 from last year (taking the \$20k out we were well above our numbers for all quarters).

In conclusion the print and online advertising sales are now on a sound footing. Many of the companies who ran in 2008 ran again in 2009 (see table below). Having begun selling contracts into 2010 it would appear we should be able to once more renew the majority and slightly increase rates over last year. I would however caution that we cannot be complacent and may need to adjust things as we go. With this word of caution I am predicting a good year with modest growth. More will be known in the next 2 months and a fuller report of 2009 projecting into 2010 will be forthcoming at PITTCON.

Report to SAS on FACSS meetings attended during the PittCon meeting in Chicago, 7 March - 12 March, 2009. John Chalmers, Jon Carnahan, Fred LePlant October 2009.

During the PittCon meeting in Chicago, the following FACSS organizational meetings were attended:

- 1. FACSS Long range planning (LRP), Sunday 8 March, 15:00-17:00
- 2. FACSS Planning committee meeting, Monday 9 March, 10:30-12:00.
- 3. FACSS Governing Board (GB) Meeting, Thursday 2 October, 12:00-14:30.

1. Some outcomes/comments/notes from the LRP Committee meeting:

- 1. Membership & Topics: FACSS is still looking closely at expanding its member societies/interest groups. As part of its aim to grow 'Separation Science' involvement, two gradient electrophoresis sessions will be introduced in Louisville (2009). Two LIBS sessions will also feature. There will be a 'new' session on Quantum Cascade Lasers.
- 2. Finances: FACSS considers itself financially sound at the moment, with reserves sufficient enough to meet the commitments for a last-minute cancellation of a future meeting.
- 3. Students: Very positive feedback had been received from the student community attending the Reno meeting (Fall 2008) that they were housed in the main conference hotel with the regular delegates, and that the social (Gala) event was all inclusive in the registration. This added to their feeling of being "a part of the meeting" and their ability to interact both formally and informally with the regular delegates. FACSS should bear this in mind for future meetings. There was some small discussion about the use of 'surplus funds' for subsidising students in the conference hotel. It was commented also that for 4-hours of help time 'student volunteers' can gain a complimentary registration. The details are on the FACSS web site, see: https://facss.org/facss/conference_students.php, they read:
- 4. STUDENT VOLUNTEERS: We are looking for student volunteers at the FACSS Conference. In exchange for 4 hours of your time, you can receive a complimentary conference registration. Call the FACSS Office at (505) 820-1648 if you would like to help or email facss@facss.org"
- 5. Maybe this is something that could be usefully brought to the attention of any SAS students intending to attend FACSS?
- 6. Site selection: The plan for future meetings is:

2009 Louisville

2010 Raleigh

2011 Reno

2012 Kansas City

2013 "wild card"

2014 Reno (with let-out clause if 2011 proves 'disappointing')

FACSS feels more comfortable now with taking a chance ("wild card") on a venue every 3-5 years, and one venue mentioned was Puerto Rico, venues in Canada were mentioned also for this slot.

- 7. LRP committee structure: There was some discussion about the LRP, its structure and its role; the LRP committee has been in operation now for about 3-5 years, during which time it had added harmony and value as enabling "more healthy conferences", "adjusting the roles of EC members", and "removing conflicts". Maybe the real role of the LRP should now become more 'visionary'; at the next meeting (FACSS 2009) it was proposed that a pre-Governing Board meeting be held to discuss this issue.
- 8. Renaming of the Conference: Again there was some considerable discussion around this, since the meeting was now 35 years old, but the conference had never actually been named! Many suggestions had been proposed, but none as yet had sparked wide enthusiasm; whatever is chosen, say, for example, "Analytical Sciences", this will be followed by "brought to you by FACSS". The rebranding must be inclusive and attract widely chromatographers, electrochemists, as well as spectroscopists, and it should be seen to be 'international'. There was some discussion as to whether FACSS should use a marketing company to suggest an inclusive name/rebrand.
- 9. Surplus: The 'surplus fund' (see previous reports) was ca. 100,000 USD. Some concern was expressed about allocating this surplus for use to member societies during the current global economic crisis. Further discussion was held over until the GB meeting later in the week.

2. Notes from the Planning Committee Meetings:

Louisville (2009):

- 1. The social event will again be an all-inclusive Gala; its theme will reflect the Kentucky Derby.
- 2. With the economic downturn, the meeting will seek to retain quality, but be responsible if suffering because of the economic situation. Generally, budgeting had been fairly frugal, so hopefully all will be OK. There is however significant concern on exhibitor and delegate numbers.
- 3. The program will feature 70-72 technical sessions. Raleigh (2010):
- 1. Dave Butcher, the General Chair, noted that in recent years FACSS attendance had been about 850, with 15-20% international, and ca. 20% 'local'. Dave felt locally there was a large pool of potential delegates, so he would also promote this also as a 'local event'
- 2. The venue will be the Raleigh Convention Centre; the hotel will be the adjoining Marriott hotel. It is ca. a 45 USD cab ride from the airport to the hotel (about 10-15 miles). There is also a super-shuttle service. There was some discussion about the possibility of laying on a shuttle service for delegates at peak times on Sunday and Thursday.
- 3. Society for Applied Spectroscopy (SAS) would like to host a lunch for its Meggers Award speakers.



3. Notes from the GB Meeting:

(This does not include items already covered above, unless additional facts are relevant.)

- 1. The nominees following were elected:
- a. GB Chair (2012-2013) Ian Lewis
- b. General Chair (2011) Greg Klunder
- c. Program Chair (2011) Pavel Matousek
- d. Secretary (2010-2011) Chris Palmer
- e. Treasurer (2010-2012) Scott McGeorge
- 2. The GB Chair, Gary Brewer, reported on a successful FACSS 2008 meeting in Reno, at which there were 835 attendees, which was good considering the state of the economy (Memphis 2007 had 857). New sessions on Archaeometry, VCD, and Food Forensics had featured and been well attended. There were 82 participants in the workshops (62 in Memphis). A surplus of around 75,000 USD was anticipated. Two particular concerns were: (i) the need to address the significant number of 'no-show' poster presenters each year, and (ii) the need for section chairs to be more disciplined in keeping to the scheduled times. FACSS short course cost have been expensive by comparison with EAS and IFPAC. The surplus from the meeting is expected to be ca. 75,000 USD. (Budget was ca. 25,000 USD).

 3. The Treasurer reported that the finances were in good shape. The 5-year average running costs of a FACSS meeting is ca. 360,000 USD. There was then some considerable discussion and argument about the disbursement of the *Surplus Fund* to FACSS' member societies, see previous reports, most particularly about whether, because of the current global economic crisis, now was an optimum time for this to happen. It was raised that the liabilities that FACSS should consider was not just the cost of one cancelled meeting but contractual costs for venues booked beyond that.

Postponement for one year was tabled. A majority vote opted for postponing a decision about the allocation of the surplus fund until FACSS' next meeting in Louisville later in 2009, at which a reassessment of its full liabilities will be discussed, the Reno meeting accounts will have been audited, and the actual effect of the economic downturn may be better evident. Next meeting, attrition measures in place: the Exhibit Chair expressed key concerns for 2009, and had scaled back space, but held room for expansion, and the hotel room block has already been reduced. The Raleigh (2010) budget has been set at -0.4%.

The next FACSS GB meeting will take place in Thursday 22 October 2009 during the FACSS 2009 meeting in Louisville.

Question 4: If your organization conducts fund-raising, how might they cooperate with CHF in ways that would mutually benefit both organizations?

3:30 pm Heritage Council Meeting Adjourns

Welcome and Opening Remarks

Chair, Jeffrey Seeman, welcomed all to the meeting, presented his thoughts about the nature of the Heritage Council and hopes for future, he explained the development of the meeting topic, outlined the plan for the day, and asked for self introduction around the room. Committee reports were also given at this time. In addition to the established committee reports, Jeff asked for the involvement of those members of the Heritage Council who have been involved since the early days of CHF to form a history focused group. These members include Ned Heindel, Shelley Isakoff, Stuart Churchill, Ernest Gilmont, and Barry Tarmy.

Introductions and Reports

Kathryn Bullock commented that in her presentation about CHF to the Electrochemical Society that they were unaware of the CHF Web Site and the educational resource represented there. She encouraged CHF to promote better this resource. A general discussion of how to promote CHF and its web site ensued. It was agreed that cross-linking web sites was a good first step. Bob Kenworthy pointed



out that CHF provides links to the home page of all Affiliates. Working with the outreach group at CHF was also suggested and will be pursued outside this meeting. Heritage Council members were asked to contact the appropriate individuals in their organizations to link CHF to the Affiliate's site.

John Baltrus noted that the Pittsburgh Conference will be coming to Philadelphia in 2013. This will represent a significant outreach opportunity. Mike Grayson noted that ASMS will be in Philadelphia in June of this year.

Membership and Nominating Committees

There was no report needed from the Membership and Nominating Committees at this time.

Bolton Society

Ned Heindel gave a brief report for the Bolton Society focused on their involvement in future conferences and symposia. A vote of thanks for years of service as Chief Bibliophile was given to Herb Pratt.

Joseph Priestley Society

The Joseph Priestley Society report was given in writing with the materials sent in advance to the HC for this meeting. Instrument and Artifact Committee (HCIAC)

Mike Grayson, who replaced Jerry Gallwas as chair at their meeting yesterday, reported on the HCIAC activities and their meeting. Since the gallery is now open and the work of the HCIAC directed toward this opening is finished, the committee is working with a draft of a new mission statement "To support the CHF in the creation of a repository of all things related to the history of chemistry, with emphasis on instrumentation in the period beginning with the electronic revolution." The primary focus of the HCIAC remains the collection of instrumentation. There was also a discussion at the meeting about the deaccession of duplicate instrumentation and how they could help the collections group at CHF in making these decisions. Expansion beyond the current scope (American) of the equipment collection to European and Asian items was also discussed. A vote of thanks for years of service as the chair of the HCIAC was given to Jerry Gallwas.

Approval of Minutes

The Minutes from the 7 November 2008 meeting were approved unanimously.

President's Report – Thomas Tritton

Tom Tritton reported to the group about the results of the planning process that was undertaken in his first year at CHF. He then gave the group a look back over the past year and a look at what is expected for the future. Included in this report was a presentation of the operating budget of CHF (attached). A significant discussion about the circumstances facing CHF then ensued. Several helpful suggestions were brought forward.

Subject of the Day – Workshop on Fundraising

Kara Mitzel and Rick Sherman made a short presentation about the technology of fund raising and development to the group and following questions, the group broke into smaller groups to discuss separate questions as follows:

Group #1 (Emmerson Bowes, Gerry Gallwas, Ernest Gilmont, Louis Hegedus, Joe Pilaro, Phil Rakita)

– Who do you think would be most likely to be willing to donate to CHF (i.e. chemistry department professors emeritus, retired CEOs)? The group focused on the development of "membership" in CHF, not for representation; such as, ACS or AlChE, but for support; like, The Smithsonian, National Geographic Society, the Metropolitan Opera, etc. There would be both individual and corporate memberships. The group then developed the following outline of the value proposition for CHF:

- Chemical Heritage Magazine
- Free Meeting Participation
- Free Joseph Priestley Society Meeting Participation
- Deeper Web Site Access
- Tax Deductible
- Individual Memberships via Corporate Memberships
- Student Memberships
- Subscription Services via ACS, AIChE, IUPAC, etc.
- Networking Opportunities via CHF Involvement; for example, a CHF based reception at an

ACS or AIChE meeting.

In a subsequent email, Emmerson Bowes pointed out that the most likely path for success would be to "go to where the money is". He elaborated, that what he is suggesting is that the marketing and public relations departments of industrial companies that are heavily dependent on chemistry (not just "chemical companies") pay for the telling of the stories about their companies and that CHF canbe a resource to these folk. The full text of his email has been passed on to Kara Mitzel and Rick Sherman for consideration.

Group #2 (Mike Grayson, Richard Howe, Marvin Margoshes, Kevin Swift, Barry Tarmy, Richard Ulrych, George Vincent) – What sources of information might exist (i.e. industry publications, awards, online communities) that CHF could use to find our next donor

Group #3 (David Alcorn, Gary Anderson) – How can the Heritage Council help CHF grow the Robert Boyle Society and the annual fund?

The group identified the following issues that need to be addressed:

- What is the Robert Boyle Society? How is it different? There needs to be a good message to the donors.
- Are there any perks associated with Boyle Society membership?
- Get help for the Joseph Priestley Society leadership in identifying potential Boyle Society donors AND give JPS leadership feedback on results.
- Is there any pre-Boyle development sequence?
- Can targeted giving be allowed without creating an unmanageable number of restricted funds and/or bookkeeping issues? Group #4 (John Baltrus, Kathryn Bullock, Roger Egoff, Ned Heindel, Sheldon Isakoff, Herb Pratt, John Sharkey, Jack Stocker) If your organization conducts fund-raising, how might they cooperate with CHF in ways that would mutually benefit both organizations? The group came up with the following recommendations in this area:

- 1. Teaching materials
- 2. Outreach to minority populations
- 3. Public image and policy accounts
